## APPROVED USER CONTRACT

Waynewood Residents

Upon execution of this contract by the Waynewood Recreation Association (WRA), the undersigned applicant(s) for WRA membership and eligible family members shall be "Approved Users" of WRA facilities upon the following terms and conditions:

1. **Term: Renewal:** This contract and the privileges conferred under it shall be effective from May 15, 2010 (or date of contract execution if later) through May 14, 2011. The contract shall be automatically renewed annually unless 1) full membership is approved by the WRA, 2) the approved user no longer wishes to participate as an approved user or 3) applicant(s) determine they no longer wish to be on the waiting list for membership.
2. **"Eligible Family Members":** means members of the family unit of the applicant(s) according to the definition of "family unit" in Article IX, paragraph 6 of the WRA By-Laws.
3. **Guests:** Guest fees shall be the same as for guests of members as set forth in the WRA rules and regulations.
4. **Privileges:** Approved Users shall have the use of all WRA facilities, and the right to participate in all WRA events and programs, on the same basis as members, but shall not have voting rights or other privileges of membership except as specified in this contract. However, eligibility for WRA teams in the Northern Virginia Swim League (NVSL) and Northern Virginia Tennis League (NVTL) is subject to eligibility criteria for those Leagues. (A) NVSL: Under current NVSL By-Laws and Rules, WRA approved users are eligible to participate in NVSL activities, provided:  
  
(1) "family members residing in the same household do not own a share of another pool in the league," and (2) "swimmers who have individual swimming privileges rather than family swimming privileges" are not eligible to compete as "approved users." The undersigned applicant(s) promise(s) to assure that any members of the family unit do not swim for WRA in NVSL meets unless they meet these eligibility rules. (B) NVTL: NVTL has advised the WRA informally

that under current NVTL By-Laws and Rules, WRA Approved Users are eligible to play on WRA teams in NVTL matches, provided that a person generally may not play for more than one club in the same league in the same season.

5. **By-Laws, Rules, and Regulations:** Applicant(s) agree that they and members of their family unit will comply with the WRA By-Laws and Rules and Regulations.
6. **Suspension or Termination:** The provisions of Article IX, paragraph of the WRA By-Laws regarding suspension or expulsion of WRA members shall also apply to Approved Users. The provisions of Article IX, paragraph 11 of the WRA By-Laws regarding termination of WRA membership shall also apply to the termination of this contract.
7. **Fees:** By execution of this contract, the WRA acknowledges receipt of the total approved user fee of **\$775.00** which covers the applicant(s) and eligible family members for the terms of this contract. The fee is composed of the following amounts:

(A) Annual Approved User Fee, equal to 2010 member dues:	<b>\$450.00</b>
(B) Administrative Fee	<b>\$ 50.00</b>
(C) Deposit Toward Membership Certificate (unless previously paid)	<b>\$275.00</b>

No portion of the fees will be prorated at the beginning or end of the contract term, unless the WRA Board of Directors in its sole discretion adopts a policy to prorate the annual Approved User Fee in a manner applied equitably to all Approved Users or grants a special prorate exception in extraordinary circumstances (such as a sudden, unforeseen need for the family to leave the area.) The Deposit Toward Membership Fee will be refunded to the applicant(s) in the fall upon request.

8. **Application for WRA Membership:** Applicant(s) have completed an application for membership in the WRA and are currently on the waiting list. Participation in the Approved User Program does not give applicant(s) waiting list priority over non-participants. **Applicant(s) agree to accept a WRA membership and pay the balance of the membership fee over and above their Deposit Toward Membership Fee, plus a \$50.00 new member fee for the first member and \$7 for each additional eligible member, within 10 days after receiving from WRA a written offer of an active membership.** If the applicant(s) have a Certificate of Interest, it will be accepted toward membership fees at its face value in accordance with Article XI, paragraph 2(a) of the By-Laws. Failure of the applicant(s) to accept a WRA membership and pay the fees within the 10 days as agreed above will constitute a breach of this contract and will result in automatic termination of this contract and forfeiture of all fees paid, except the WRA Board of Directors, in its sole discretion, may extend the 10-day period for good cause shown.
