Welcome to the Waynewood Recreation Association. Our Association is very active, offering members both swimming and tennis facilities. We have tennis and swimming lessons for children, as well as swim and tennis teams. We offer tennis lessons and teams for adults.

Our complex is composed of three lighted tennis courts and three pools – a lap pool, an L-shaped pool with a diving area, and a baby pool. Our grounds include picnic areas, basketball courts and playing fields. The pool opens the Saturday before Memorial Day and closes Labor Day. Tennis courts are open for play year round.

There are social events for both adults and children. Volunteers run all the social events and we are always open to suggestions for new events. Social activities include the annual 4<sup>th</sup> of July celebration and numerous parties for both adults and children. Contact the board if you would like to help with any event. Come meet your new neighbors.

To become a member of the Association, each family purchases a \$550 membership certificate which is redeemable upon quitting the association or leaving the area. Each new family is charged a one-time-only \$50 membership fee and \$7 for each additional family member.

The yearly dues are based on the number of members and our yearly budget, and are voted on by the membership at the annual February meeting. The dues are always due early May.
